Travis Tauer gave an update on Public Works. The well project is coming along.

Chris Fischer gave an update.

A Special Meeting is scheduled for September 13<sup>th</sup> at 7:30a.m. to go over the 2026 budget. A posting will be put on Facebook.

Darren Willga, 204 E. 2<sup>nd</sup> Street, is inquiring about purchasing the adjacent property. This property is owned by the City. The reason the city owns this parcel is for the line of sight at the intersection for the semis and tractors as they entered and left the coop. Chris Fischer will discuss with Darren his plans to see if the 40-foot line of sight can still be accomplished.

EDA will have a new tenant in #3, Clayton Neville starting in September. The AC unit went out in #3 and had to be replaced.
